Agreements

The nations of the Orange-senqu River basin are party to many regional and bilateral institutional arrangements and agreements. These institutional structures support the development and management of international river basins that the riparians share with neighbouring countries.

Botswana

- The Agreement with South Africa to transfer water from the Molatedi Dam on the Marico River, a tributary of the Limpopo, in South Africa to Gaborone in Botswana (1988).
- The Joint Permanent Water Commission (JPWC) with Namibia to address issues related to the Kwando-Linyanti-Chobe river system (1990)
- The Permanent Okavango River Basin Water Commission (OKACOM) with Angola and Namibia on the Okavango River (1994)
- Zambezi Water Course Commission (ZAMCOM) involving Malawi, Tanzania, Zambia, Angola, Namibia, Mozambique and Zimbabwe (2004).
- The Limpopo Basin Permanent Technical Committee (LBPTC) with South Africa, Mozambique, and Zimbabwe (1986)
